

- Proof of burial responsibility (e.g., letters from JP, Pastor, or Senior Police Officer)
- Financial need assessment
- Employer documentation of benefits
- Disclosure of other support sources

- Seasonal campaigns (e.g., Senior Citizen Treat, Back to School support etc.)
- Partnerships with churches and NGOs
